The students of Eco-clubs/NGC are involved in disseminating various environmental aspects through awareness programmes such as organizing rallies, human chains, seminars, workshops, tree planting, campus cleaning etc., However making use of the popular latest versatile, easily accessible media power have not yet been captured to reach even the unreached besides lake of motivation advertisement non-capitalization of the skill of the current generation. Moreover, piece meal making of video films found not only expensive but also donot capitalize the talents of the younger generation.

Hon, ble Minister for Environment Announcement 2018-19, to great awareness from public go for Best Advertisement Film contest on Environmental Protection, over any topic/theme on land, air, water, forest, industrial activities, flora, fauna etc., and fit for telecasting in the public media, through Producer/ advertisement Ad-Films invited from Film Director/Institutions/Individual via CD/DVD/PenDrive before on or 15/12/2018.

The Best first three ad-films will be selected and will be given a Cash prize of Rs.7.00 lakhs, Rs.6.00 lakhs & Rs.5.00 lakhs respectively besides certificates by the Hon'ble Chief Minister of Tamil Nadu in an appropriate forum.

- 1. The ad-film should be produced in the State focusing the environmental related issues of the State.
- 2. The Director of Environment will have for the legitimate ownership of the ad-films received for awards.

- 3. The selected and un-selected ad-films for the awards will not be returned to the producers and no royalty will be given.
- 4. The Department of Environment will have the right to make any change/ modification/ alteration in the ad-films, as deemed fit and necessary, without the consent of the producer.
- 5. The producer should edit / modify the film, as requested by the Department of Environment, if necessary, if the said film is considered for telecasting.
- 6. The name of the producer will be indicated while telecasting the adfilm in the public media.
- 7. The theme/ idea/ topic of the ad-film should be of the producer and should not be copied or remake of the others. If any objection or complaint is received, in this regard, it is the liability of the producer to prove the truth that the ad-film is of his own product.
- 8. One can produce and submit any number of ad-films within the timelimit/
- 9. The personalities ,if any,in the ad-films should not be controversial person from Tamilnadu
- 10. The ad-films should be produced in the Tamil language only.
- 11. The theme/ topic/ idea of the ad-film should not contrary or criticize the Government programmes / polices.
- 12. A Juries of selection will be formed and the Member of the Juries will select the awardees. The verdict of the members of the Juries is final and any request for reconsideration is not allowed
- 13. Copies of the ad-films will be hosted in the media ,official websites of Department of Environment and others and also be sent to NGC & Ecoclub schools for telecasting in the school functions, prayer meetings, etc.,
- 14. Ad-Film for the awards should be reach this Directorate on or before 15th December 2018.
