

Press Release**DIRECTORATE OF INDIAN MEDICINE AND HOMOEOPATHY, CHENNAI – 106.****CORRIGENDUM to the Notification dated 12.08.2018.**

Applications were invited and processed for admission to BSMS / BAMS / BUMS / BHMS / BNYS courses 2018-19 session in Government and Self Financing Medical Colleges in Tamil Nadu from the candidates who have passed Higher Secondary Course (with science subjects) in first appearance.

2. As per the Amendment made in the G.O.(D) No.1373/ Health and Family Welfare Dept., dated 01.08.2018 in the Minimum Eligibility Marks clause for certain communities in the Prospectus for Admission to BSMS / BAMS/ BUMS / BHMS / BNYS courses vide G.O.(D) No.1802/ Health and Family Welfare Dept., dated 16.10.2018, in pursuance with the observations made with respect to left out rules on 12.10.2018 during the hearing of the Hon'ble Madras High Court in the Writ Petition No.27006 of 2018, fresh Applications are invited **ONLY** from the eligible candidates who have passed 12th Standard with science or any other equivalent examination recognized by University or Board in one and the same attempt and who fall, under the below mentioned Communities for admission to BSMS / BAMS/ BUMS / BHMS / BNYS courses during the Academic Session 2018-19.
