ஹரியானா மாநிலம், சுரஜ்குண்டில் இன்று (28.10.2022) நடைபெற்ற மாநில உள்துறை அமைச்சர்கள் மாநாட்டில், மாண்புமிகு தமிழ்நாடு முதலமைச்சர் திரு.மு.க.ஸ்டாலின் அவர்கள் சார்பில் மாண்புமிகு சட்டத்துறை அமைச்சர் திரு.எஸ். ரகுபதி அவர்கள் கலந்து கொண்டு பேசியதாவது:

மாண்புமிகு தமிழ்நாடு முதலமைச்சர் திரு.மு.க.ஸ்டாலின் அவர்கள் தலைமையின் கீழ், மிகவும் அமைதியான மாநிலமாகத் இந்திய ஒன்றியத்திலேயே தமிழ்நாடு திகழ்ந்து வருவது குறித்தும், தமிழ்நாடு அரசு, மாநிலத்தில் அமைதியான சூழலைப் பேணிக்காத்து வருவதுடன், மாநிலத்திலுள்ள மக்கள் பாதுகாப்பு உணர்வுடன் வாழும் சூழலை உருவாக்கி, சட்டம் ஒழுங்கை சிறப்பாகப் பராமரித்து வருவது குறித்தும், காவல்துறையினை நவீனமயமாக்கல் மற்றும் செலவிடப்படாத நிதி குறித்தும், தண்டனை விகிதத்தைப் பொறுத்தவரை, தமிழ்நாடு தேசிய சராசரியான 78.7 விழுக்காட்டைவிட அதிகமாக 93.5% விழுக்காடாக இருப்பது தொடர்பாகவும், தமிழ்நாட்டில் உள்ள எதிரி சொத்துக்கள் தொடர்பாக அரசு எடுத்துவரும் நடவடிக்கைகள், இந்திய காவல் பணி அதிகாரிகளின் மனிதவள மேம்பாடு, தமிழ்நாட்டிலுள்ள வெளிநாட்டினரால் ஏற்படும் பிரச்சிணைகள், இலங்கைக் தமிழர்கள் மற்றும் உள்நாட்டுப் பாதுகாப்பு தொடர்பான சவால்கள், தமிழ்நாடு அரசு எடுத்துவரும் போதைப்பொருள் எதிர்ப்பு நடவடிக்கைகள், பெண்கள் மற்றும் குழந்தைகளுக்கு எதிரான குற்றங்கள் மீது எடுக்கப்பட்டு வரும் நடவடிக்கைகள், சைபர் கிரைம் குற்றங்களை தடுப்பதற்கு எடுக்கப்பட்டு

வரும் நடவடிக்கைகள், கச்சத்தீவு விவகாரம், கடலில் உள்ள பூஜ்ஜிய அளவு நீர்ப் பொதுப் பகுதியில் தமிழக மீனவர்கள் எதிர்கொள்ளும் பிரச்சினைகள், இலங்கை கடற்படையினரால் நிகழ்த்தப்படும் துப்பாக்கிச் சூடு சம்பவங்களில் உயிரிழந்த / காயமடைந்த தமிழக மீனவர்களின் குடும்பங்களுக்கு வழங்கப்பட்டு வரும் நிவாரணங்கள் ஆகியவை குறித்தும் உரையாற்றினார்.

Hon'ble Union Home & Cooperation Minister Thiru. Amit Shah, the Hon'ble Chief Minister of Haryana Thiru Manohar Lal, Honourable Chief Ministers of various States, other Central and State Ministers, Secretaries of various States and other dignitaries in this Conference, very good morning to all.

Our State of **Tamil Nadu** is the most peaceful State in the Union of India, under the **Chief Ministership of our Hon'ble Thiru. M.K. Stalin**. Our Government maintains peace as well as creates an environment where our people can feel and live protected by the Government. We not only maintain Law and order but also created an environment to avoid even squabbles to big issues like terrorist bomb blasts.

In the last week Our State of Tamil Nadu has declared, the National Security Agency office situated at Chennai as a Police Station, by issuing Notification for the purpose.

The Modernization Police and Unspent Balances

The Modernization of Police force Scheme is a centrally Sponsored Scheme shared between the Union and State Governments under the Grant in aid scheme of "Assistance to State for modernization of Police (ASUMP). A matching grant is provide by the State Government.

For the past 10 years the Union Government have released Rs.593.83 crores under this Assistance to modernization and our State of Tamil Nadu have sanctioned Rs.356.70 crores for this purpose. In total our State has spent Rs.716.98 crores out of the funds released Rs.950.53 crores.

The Balance amount Rs.233.55 crores could not be spent since Tenders or Re-Tenders have to be floated in certain cases, Supply awaited in certain cases, Quality check has to be conducted in certain supplies, payment is under process and in certain items Alternative items are to be proposed and purchased. Action will be taken expedite to incur the expenditure pertaining to unspent items.

Remaining unspent amount of Rs. 38.76 crores will be utilized during the month of December 2022.

The delay in procurement was mainly due to Covid 19 Pandemic situation and various firms are not able to supply the items in which they are not able to meet out the specifications. Hence their supply orders were cancelled and re-tendered.

Higher Conviction Rate

So far as the conviction rate is concerned our State is nearly 15 % more than the national average of 78.7 %. In the year 2021 our conviction rate is 93.5 %.

Enemy Property.

Total Enemy properties vested in the Custodian of Enemy Property for India (CEPI) are 2,111 which includes 217 properties involved in court cases relating to income and declaration. In addition to these, there are another 1,230 enemy properties of Pakistani nationals which are either under part process with the CEPI or are under litigation. The 2,111 Vested enemy properties, (i.e.) 62 properties of Chinese Nationals + 2,049 properties of Pakistani national) and 1,230 properties of Pakistan nationals are still under the process of Identification.

On 14th March 2017, the Enemy Property Act, 1968 was amended by the Enemy Property (Amendment and Validation) Act, 2017. Now Home Ministry is in the process of framing the rules and guidelines for implementing the provisions of the Act.

As requested by the Government of India, the Secretary, Revenue and Disaster Management Department nominated as the Nodal Officer for framing Rules and Guidelines for implementing the provisions of the Amendment Act and subsequently, the Commissioner of Land Administration was nominated as the Nodal Officer for our State.

The Union Ministry of Home Affairs has requested the State Government to take following action in respect of enemy properties situated in Tamil Nadu:-

- i. The title enemy properties has to be changed in the name of Custodian of Enemy property of India in the Record of Revenue (RoR) as the owners.
- ii. The Valuation report of all the Enemy properties have to be sent.
- iii. The rent that is being paid by the present tenant's of leased properties have to be compared with CEPI and if it is less, then the same can be revised.
- iv. Necessary action has to be taken to free encroached Enemy properties.

Necessary instructions in this regard have been issued to the concerned District Collectors and it is under process.

Human Resources Development of IPS officers.

The Tamil Nadu Police (Reforms) Act, 2013 was enacted to carry out the directions of the Hon'ble Supreme Court in Prakash Singh case regarding Police reforms. Further this Act was enacted, taking into consideration of the following aspects of the Model Police Act:-

- a) Appointment of Director General. Additional Directors General. Inspectors General. Deputy and Assistant Inspectors General
- b) Selection and term of office of the Director General of Police

- c) Term of office of key police functionaries
- d) Superintendence of state police to vest in the State Government
- e) State Police Board
- f) Composition of the Board
- g) Composition of the panel for selection of Independent Members
- h) Method of selection
- i) Expenses of the State Police Board
- j) Annual report of the State Police Board
- k) Administration of Police Service
- 1) Powers and responsibilities of the Director General of Police
- m)Police Establishment Committees
- n) Procedure for promotion of police officers
- o) Police Accountability
- p) Accountability for conduct
- q) Composition of the Commission

By and large the provisions of Model Police Act has been adopted in the State of Tamil Nadu.

Foreigners Issues in Tamil Nadu

Foreigners staying in private houses miss use form C registration in some cases and in such issues regular cases are registered against them. Further, foreign Students prolong their stay, involve in smuggling activities, unofficial employment, forming informal associations, using social media, etc. are some of the issues faced in the State.

Srilankan Tamils and Internal Security Challenges

Refugee Camp:

As on 08.10.2022, 91,761 Srilankan Tamils refugees residing in the State, of which

- ➤ 58,171 Srilankan Tamils are living in 107 recapitalization camps spread across the State.
- ➤ 33,590 Srilankan Tamils are living outside the camp.
- ➤ Efforts are being are taken to deport them or extend their Visa, if eligible.

Recent Influx due to economic crisis

As on 08.10.2022, 176 Srilankan Tamils have arrived at Ramanathapuram District from Srilanka and they are accommodated at Mandapam Srilankan Tamil Rehabilitation Camp.

Meantime, 99,469 Srilankan Tamil refugees were sent back to Srilanka with their willingness in two phases.

Special Camp, Trichy

At present, only one special camp in Tamil Nadu is functioning i.e., at Trichy, with 131 inmates (concerned in 103 cases) - Sri Lankans (Tamil-73, Sinhalese - 6), Bangladeshis - 33, Iran - 7, Nigerian -5, Chinese - 2, Each one Russian, Bulgarian, Mexican, German, West African.

Further the Rohingya Muslims started coming to Tamil Nadu since February 2014 and currently 85 Rohingyas are staying in Tamil Nadu.

Of late, Bangladesi nationals are residing illegally in various districts of Tamil Nadu, particularly in Tiruppur City, under the guise of Bengalis of West Bengal.

<u>Anti - Narcotic Drug Actions</u>

Tamil Nadu Government has taken the issue of narcotic drugs with utmost seriousness and steps are being taken to usher in a drug free Tamil Nadu. Our Hon'ble Chief Minister has conducted first ever State Level Conference of District Officers and Senior Police Officers on the above subject on the 1st August 2022.

During the Ganja & Gutkha operation from 06.12.2021 to 05.01.2022 a total number of 1272 NDPS cases have been booked resulting the arresting of 1221 accused and sized 2299 kgs of Ganja and 23 kgs of Heroin.

Crime Against Women and Children

For any emergency, Our state has created 'Kaval Uthavi APP' Women in distress can press the phonic button in the App or otherwise they can just shake the mobile three times, then the message goes to control room and nearby patrolling vehicle or beat or Police Station will take care of the issue. SOS button can also be used in this APP.

For preventing crimes against women and Children in Chennai City and exclusive 'Pink Patrol' is arranged under a women officer.

63,948 Awareness Campaigns and 1,108 Awareness Rallies were conducted and Training camps are also conducted periodically. A Cyber Crime Police Station is also functioning exclusively to prohibit crimes against women and children in Chennai. Helpline Numbers to report the crimes are being provided State Level.

Cyber Crime Issues:

As per NCRP Portal, Number of Complaints reported in Tamil Nadu for the year 2022 is 45,448. We have registered nearly 2,430 FIRs. Total amount frozen is Rs.67.3 crores.

People are still unaware about the Helpline Number 1930. It must be included in SMS sent by Banks and displayed in their websites.

The helpline Number 1930 must be integrated to Citizen financial Fraud Reporting System with bank websites and Apps. If

the transaction is fraudulent, there should be an action button below the transaction as 'Report to 1930'. Just by pressing that button, the victim may be able to report about the fraudulent transactions to the Banks.

Katchatheevu issue:

Katchatheevu originally belongs to Ramnad Kingdom of Ramanathapuram, which came under the Madras Presidency during the British Rule of India. During 1974, the then Prime Minister ceded Katchatheevu to Sri Lanka under the Indo-Sri Lankan Maritime Agreement. Considering the Fishermen's and other issues, Government of India may consider to take necessary action to reclaim and bring back it under India's Sovereignty. If necessary the International Court of Justice may also be approached for this purpose.

Fishermen issue at Common Area in Sea - Zero Water Level:

Indian Fishermen report that they are fishing in the Common Area in Sea - Zero Water Level and not in the Areas belong into Sri Lanka. But, the Sri Lankan Navy used to round up them and push the Indian Fishermen to their Areas and then arrest them. Action has to be taken by the Government of India to curtail these types of catching of Fishermen by bringing / pushing them to Sri Lankan Sea Zone.

Relief to the families of deceased fishermen/ injured fishermen due to shooting incidents by Sri Lankan Navy

The Government is providing an ex-gratia payment of Rs.3 lakh from the Chief Minister's Public Relief Fund to help the family of fishermen who die in shooting at sea.

In the case of deceased fisherman being the sole bread-winner of the family, an ex-gratia amount of Rs.5 lakh is provided.

If the fishermen sustain major and minor injuries, an ex-gratia amount of Rs.50,000 and Rs.20,000 is provided, respectively.

As majority of the above issues are not State specific, the Government of India may take appropriate action to resolve them in co-ordination with the concerned Ministries.
