In the meeting, Thiru N. Muruganandam, IAS., stated that Tamil Nadu is the leading state Automobiles, Textiles, Leather, Electronic manufacturing, Software Industry and the success of Global Investors Meets have attracted largest number of investors. He made presentation on the upcoming New Industrial Policy with objectives to evolve ease of doing

business, providing world class infrastructure, competitive fiscal incentives, balanced regional development and employment generation.

Hon'ble Vice Chairman, State Development Policy Council, Thiru C.
